

Rector's Report

2021 was another challenging year. We began the year by continuing virtual services and meetings. When the COVID vaccines were finally available to the majority of our population, the Vestry and I decided that it was time to resume in-person services. The first Sunday we resumed in-person services was May 2. Although we have resumed our in-person services, we continue to limit some of the gatherings we would like to have. I look forward to the time when we can once again have a coffee hour and gather for meals and receptions in the church.

In addition to returning to in-person services, we have been able to gather for some other functions. The MOD Squad has gathered for dinners at various restaurants. The same is true for our cluster dinners. We have resumed Bible Study at 9:00 a.m. on Sundays. The Vestry and I will continue to monitor the COVID numbers to discern how we should be gathering in person.

Our Parish Administrator, Katie Kuceyeski, and I are grateful to have moved our offices to the area that was formerly used as the Coat Room and Nursery. The old Rector's Office is being transformed into the nursery. The primary reason for making this move was to have a place where I could meet with members of the parish in a quiet setting and can work without listening to the kindergarten lessons through the wall. Although this move was proposed by Interim Rectors, the decision to make the move was postponed until my arrival so I could have input in the final decision. The move has created a much more productive workspace.

Going forward, I have set five goals for St. Mark's to achieve. The first is to establish an Outreach Committee. By the end of the year, I hope that this Committee will lead us to at least one outreach program that any member of the parish can be involved with. We have many people engaged in various outreach programs, and I am encouraged by their efforts. At the same time, I believe it will increase the health of St. Mark's if we have an outreach program in which we can all work side by side.

Second, I hope to build a stronger relationship with Weaver Child Development Center. The Director of the School, Susie Maioriello, and I have begun a dialogue to explore how St. Mark's might minister to the students and/or faculty. Engaging in some way with the formation of the children at the school is an excellent way to reach the next generation. It may also open opportunities for us to get to know some of the families who are involved with the school.

Our third goal is to add at least six households to our parish this year. A household may be a single person, a married couple, or a family with children. To some, this may seem like a small number. New members bring more new members. Perhaps the best way to start moving toward this goal is for every current member to begin praying that the Holy Spirit will open their hearts and minds to see who they might invite to join us and to pray for friends, neighbors, and family members who do not currently attend a church. Prayer changes the world, and prayer changes us.

The final two goals are longer-term goals. The fourth goal is to have an average Sunday attendance of at least one hundred people within five years. St. Mark's is a wonderful community. What we have here is worth sharing with others.

Finally, within five years our budget will not need to include money from the principal of the endowment funds. It is not bad to have to rely on the principal from the endowment for a time to rebuild. However, it is not a sustainable strategy in the long run to spend more than our income. If we achieve the first four goals, this fifth goal should be a natural byproduct.

I am grateful for the community of St. Mark's, and for the strong lay leadership that is here. I believe that God, through the power of the Holy Spirit, has good things in store for this parish. As people re-engage the world following the pandemic, many people are looking for deeper personal connections. This is something we have to offer. This is an authentic community that is willing to integrate people with various viewpoints. That is something our world desperately needs now. That is the gift we can give to people from Canton and the surrounding communities.

When my caregiver Ray developed health issues, St. Mark's ladies came through with sumptuous meals; and Tony's "Men's Out Dining" has been a way to connect.

Bruce Schutrum played a two-piano piece by Franck with me – it's quite special to have two pianos in the chancel. Our organ, functioning so well since 2002, had a two-week respite in the Fall because of a faulty computer board, ably repaired by our organ men, Jon, and Greg Lester.

International musician Steve Grimo loaned us his timpani and his talents and those of his friend Jan Bafrtchy for several festive services. Guests Catherine Elsass Dillon and her teacher Jean Couchie Burnquist have sung special solos.

John Wise, Joe Hoot, Bruce Hixon, and Geoff Gordon have pooled their talents to permit streaming of our services online. I love playing bell introductions since our organ is equipped with lots of percussion. Thanks to Bruce Kennedy, who videoed an organ improv at my house in early December, and Anthony Montagno, parish musician at Trinity UCC and editor of our Canton Organ Guild publication, a YouTube of this Christmas Medley is available on the internet. This is my 24th year at St. Mark's — a place of warm Christian fellowship.

Greeters/Welcome Guild

With the suspension of in-person services until the month of May, greeters were not needed. Then services were begun in our outdoor chapel, which our congregation is thankful to have.

As previously done in 2020, under the direction of Katie Kuceyeski, our administrative assistant, a welcome table was set up outside, weather permitting. These directives were followed by a handful of faithful, masked volunteers who staffed the table each Sunday during the summer. They kept a contact-tracing list, supplied masks if needed, and encouraged folks to use hand sanitizer, all while providing a friendly greeting and reminders to wear a name tag!

We four of the WELCOMING GUILD have reinstated the recruitment of weekly greeters for the 10 a.m. service. Fellow parishioners are happy to be part of this ministry. Currently, masks are to be worn, but we no longer are keeping contact tracing lists. Greeters can direct visitors around our building, offer them a VISITOR BAG, suggest that they sign the guest book, and introduce them to Fr RJ. We may not see each others' smiles nor shake hands, but our eyes and words can offer a hearty welcome to all who attend our services

Our mission is to welcome fellow parishioners as well as visitors. Hospitality is a gracious Christian attribute. We are welcoming folks into God's home, as we would welcome family and friends into our own.

Hope Outreach Ministry

OUTREACH: Blessing Box at Hope Outreach Ministry

St. Mark's continued its long relationship with Hope Outreach Ministry this year by operating a collection center for Hope's Blessing Box Project. The Blessing Box at Hope is stocked with personal care items and emergency food items and is open to the homeless 24 hours a day. St. Mark's collects these items in its own "Hope Chest" located by Katie's new office, and then delivers them to Hope. About 30% of the families served by Hope are homeless, including children. We also collect any used clothing items to deliver as well. This year something special happened when the Weaver School at St. Mark's did outreach for Hope also. The children made "care bags" to hand out to the homeless and made Thanksgiving cards to pass out as well. Thank you, Weaver School.

The Columbarium is a wonderful gift that past and present parishioners have given to the St. Mark's Family. Many parishioners have reserved a place for themselves and their immediate

families. Sixty-eight of the 152 niches have been sold. This year two families have interred loved ones in the St. Mark's columbarium.

The cost today is \$1,000. This covers the niche, maintenance, and gold lettering. Not only is this considered a bargain in funeral costs, but it also eliminates worry and expense at the time of your funeral. Niches are sold as single units and are designed to accommodate both husband's and wife's ashes (if care is taken selecting the urn). Engraving is a standard design for all niches and there are no variations.

The placement of your remains is an important part of your funeral planning, but not the only part. We also recommend you spend time with the priest outlining your funeral wishes.

Parish Notecards

The inside inscription of our parish notecards reads: Your family of St. Mark's is thinking of you". The notecards are sent 3 – 4 times a year, at non-holiday times. Recipients typically are parishioners only and include those who are shut-ins, on our prayer list from the bulletin, and who are experiencing challenges in their lives. There are a variety of reasons that folks are not able to attend our Sunday services. The Parish Notecard Ministry is an opportunity to let them know that they continue to be part of our St. Mark's family.

The first "round" was sent in mid-February to 11; the second "round" with 12 sent in mid-July; the third "round" with 18 sent in late November.

Due to the pandemic, we three ladies wrote them at our respective homes. (Previously we met at church and all signed each one.). We handwrite a sentiment chosen by us – often a Bible verse or phrase from The Book of Common Prayer—unique to the recipient. Our sentiments are heartfelt and are intended to be inspirational and supportive.

We each said a prayer for each recipient prior to passing them on to Fr RJ. He signs and mails them.

We look forward to continuing this "behind the scenes" ministry and hope that we can soon resume writing them together at our church.

As a side note, the 4 p.m. Wednesday zoom Evening Prayer is an opportunity for an interactive, corporate worship service that can be "attended" from anywhere with WiFi.

St. Mark's Annual Meeting Minutes January 17, 2021

1. Call to Order

- The Annual Meeting was held virtually via Zoom in compliance with prohibitions on inperson gathering from the Diocese and the State of Ohio in response to the COVID-19 pandemic.
- Parishioners began logging into the Zoom meeting at 10:03 a.m., introducing themselves to Fr. RJ.
- The meeting was called to order at 10:18 a.m. when a quorum was attained.

2. Opening Prayer

• Fr. RJ Johnson opened the meeting with a prayer.

3. Determination of a Quorum

A quorum was declared, with 38 eligible parishioner logins to the Zoom meeting.

4. Adoption of Time Allotment / Speaking Rules

The Trustees of St. Mark's manage all endowment funds for the church. Endowment Funds are made up of bequests and donations which generous parishioners and friends have given to St. Mark's to ensure the longevity and well-being of the parish. With the creation of the trust,

past parishioners wanted to set up a tool to benefit the church and a vehicle to provide funds for projects and needs beyond normal operating requirements.

There are five Trustees who serve five-year terms (maximum two consecutive terms) and who oversees the investment and distribution of the funds. Trustees for 2021 were:

Assets are currently invested in equities, income funds, and money market funds. A small portion of the assets, church library, and music program, are restricted to disperse only income. The balance of the fund is available to be used for the benefit of the church with the approval of the Trustees and Vestry.

Expenses reflect how we utilize that bounty of funds to pursue God's call. <u>Allocation of expenditures to each of our four mission</u> areas allows us to reflect on how we are fulfilling the various aspects of our mission and to determine if

<u>adjustments should be made.</u> This examination is not just about money, but also the energy, time, and gifts of St. Mark's clergy, staff, and laypersons.

The Finance Committee offers this 2021 Financial Report and 2022 Missional Budget not only as a tool to analyze our financial realities, but more importantly to launch consideration of how we are responding to God's call for us as a community to pursue both "inward-focused aspects of mission (worship; teaching; pastoral care; fellowship), and ... outward aspects (evangelism; outreach; advocacy)." 2021 Financial Reports

Dear Parishioners,

Throughout 2021 I have worked closely with the Finance Committee, the Trustees, the Vestry, and Father RJ. to receive, care for, and properly distribute the financial resources you have provided to support the mission of St. Mark's. This report has been designed to provide you with a clear and accessible picture of what resources have been received and how they have been used to further our work. Please do not hesitate to ask me or any member of the Finance Committee about this report or any other financial matter.

A special thank you to John Willoughby, Sara Strattan, Kathy Kennedy and Geoff Gordon for their support and work on the Finance Committee, as we worked through our first full year with a full-time rector, surprise HVAC issues, and relocating the church offices. It is important to recognize the significant amount of work done by Katie Kuceyeski, our office manager, and by John Wise and Bruce Hixon, our wardens. Due to COVID, the number of offering counters was reduced. Joe Hoot and Geoff Gordon handled most weeks with some help from Bob Kocab, Christy Thorley, and Rick Werren.

As expected, operating expenses exceeded operating income in 2021. In March, monthly withdrawals of \$4,000 were transferred for the St. Mark's Trust to support operation expenses. The use of Trust funds was reviewed and approved by the Vestry and the Trustees in 2019 to support the hiring of a full-time rector.

After reviewing the year, we find that there are a number of things which stand out. Among them are:

- <u>Operating Costs</u>: Operating costs are expected to exceed operating income for the next several years. As we break free from the COVID pandemic, we need to develop plans to increase the overall participation in the spiritual gifts offered here at St. Mark's.
- <u>Donations</u>: The COVID-19 crises continued to have a significant financial impact on donations in 2021. Again, this year we obtained a \$18,700 SBA PPP loan and successfully filed for forgiveness. With the SBA PPP loan, a special donation, and some parishioners exceeding their pledge donation, total revenue exceeded the budget by \$26,472.
- <u>Outreach Activities</u>: COVID-19 also had a significant impact on our Outreach activities. Personal involvement was limited, if any. Thanksgiving Baskets and Community Christmas asked for only cash donations again this year. In 2021, parishioners donated \$4,475 to be sent to outside organizations.
- <u>Capital Improvements</u>: In late summer, our 40-year-old sanctuary air conditioner decided to retire. A
 special thank you to the many parishioners who contributed to the special AC fund (\$15,500 was donated).
 Following the recommendation of our interim rectors, the church offices have been moved. For a
 complete list of 2021 Capital Projects and funding, see the attached 2021 Capital Reserve Financials sheet
 attached.
